STATE HIGHWAY 37 SOUTH, which is South Main St. within the city limits and all contacts and or citations issued therein have been categorized under City Streets in the past and not a State Highway.

Second: STATE HIGHWAY 154 WEST, which is West Bermuda St.within the city limits and all contacts and or citations issued therein have been categorized under City Streets in the past and not a State Highway.

STATE HIGHWAY 154 EAST, which is East Goode St. within the city limits and all contacts and or citations issued therein have been categorized under City Streets in the past and not a State Highway.

Third: FARM TO MARKET ROAD 778, which is Horton St. within the city limits and all contacts and or citations issued therein have been categorized under City Streets in the past and not a Farm to Market Road.


