

**REGULATION OF ALCOHOL ON PUBLIC
PROPERTY
ORDINANCE 041918 (1)**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF QUITMAN, TEXAS
AMENDING THE CITY OF QUITMAN - CODE OF ORDINANCES
REVISING REGULATIONS RELATED TO ALCOHOL ON PUBLIC PROPERTY;
PROVIDING A PENALTY CLAUSE; PROVIDING AN EFFECTIVE CLAUSE; AND PROVIDING A
PUBLICATION CLAUSE**

WHEREAS, the City of Quitman has heretofore adopted Ordinance No. 031518(02) entitled Regulation of Alcohol on Public Property: and

WHEREAS, the City Council has determined that it is necessary to amend such ordinance in order to promote increased commercial and philanthropic activities within the City which the City Council finds to be in the best interest of the community provided well-regulated and managed policies;

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF QUITMAN THAT SECTION 113.03-4 OF THE CODE OF ORDINANCES OF THE CITY OF QUITMAN ARE HEREBY AMENDED TO PROVIDE AS FOLLOWS:

PART I

"Section 113.03 - Consumption on Public Property

1. It shall be unlawful for any person to consume any alcoholic beverage while on any public property, except as follows:
 - A) At the Carroll Green Civic Center (CGCC), during special events which have been approved by the City Council or by the Mayor.
 - B) At the Stinson House located in the Jim Hogg City Park, in accordance with the policies of the Friends of the Arboretum Board as approved by the City Council.
 - C) At Jim Hogg Park during special events which have been approved by the City Council or by the Mayor.
 - D) At the City Square and immediately adjacent areas during special events which have been approved by the City Council or by the Mayor.
 - E) At the Quitman Development Corporation Property located at 113 Lipscomb Street and immediately adjacent areas during special events which have been approved by the City Council or by the Mayor.
2. No event at which participants are allowed to consume alcoholic beverages upon public property shall be permitted unless and until all permits required of such event by the Texas Alcoholic Beverage Commission shall have been acquired.

The penalty for a violation of this section shall be in accordance with Section 10.99 - General Penalty of this Code."


PART II
