TRAFFIC REGULATIONS

§ 70.01 SPEED LIMITS.

Upon the basis of an engineering and traffic investigation heretofore made as authorized by the provisions of Tex. Transp. Code § 542.202, the prima facie speed limits hereafter indicated for vehicles are hereby determined and declared to be reasonable and safe; and such speed limits are hereby fixed at the rate of speed indicated for vehicles traveling upon the named streets and highways, or parts thereof, described as set forth in Chapter 72, Schedule I.

§ 70.02 CROSSWALKS.

Crosswalks shall be designated and so marked by the city, in locations as set forth in Chapter 72, Schedule III.

PARKING REGULATIONS

§ 70.15 SPACES MARKED "NO PARKING."

- (A) It is unlawful for any person to park any motor or other vehicle in any area marked "No Parking" within the city limits. Such places so marked shall be designated by the City Council of the city of Quitman.
- (B) All illegally parked vehicles are subject to be towed away. (Ord. 960815, passed 8-15-1996) Penalty, see § 70.99

§ 70.16 STANDARDS FOR LONG-TERM PARKING OF RECREATIONAL VEHICLE.

- (A) The purpose of this section is to set standards for the long-term parking or storage of any recreational or other special vehicle, as defined in this section, in any residentially zoned district.
- (1) **RECREATIONAL OR SPECIAL VEHICLE.** Any camper, travel trailer or other trailer (including boats, autos, or any other item stored thereon), designed to be towed on public streets and which exceeds 22 feet in length; or any motor home, coach, bus or other self-propelled vehicle which exceeds 22 feet in length.
- (2) **VEHICLE LENGTH.** Shall be measured to include the trailer tongue and other connections, and any overhang of the vehicle or trailer, including the item(s) being transported on the trailer.
 - (B) All RVs that are stored and/or parked must meet the following conditions:
- (1) The RV must have a current and valid registration and a current and valid license plate affixed thereon;
- (2) The RV or accessory recreational vehicle must not be wrecked, dismantled, partially dismantled, inoperative, abandoned or discarded;
- (3) The RV or accessory recreational vehicle shall not be used for living, sleeping or housekeeping purposes anywhere other than a licensed park;
- (4) RVs, travel trailers, campers and the like may be parked and/or stored in the rear or side yard. If the side yard is adjacent to a street, the RV must be a minimum of 15 feet from the side property line. They may not be stored in the front yard. The front yard is the area (paved or not) across a line that is parallel to the front edge of the dwelling and extending to the side property lines and running along said property lines to the street;

- (5) RVs may be parked for a period of 72 hours during loading and unloading only, in the front driveway or on the street. This requirement does not apply in 2 specific situations. In the event guests, friends or relatives are using either their own RV or an RV owned by the Quitman citizen on a temporary basis as living quarters, such use is permitted for a period of 72 hours. A permit must be secured from the city to extend the use for an additional period up to 14 days; however, such extension permit can be secured only 1 time in any one 6-month period. No fee shall be required for the permits described above;
- (6) Long-term parking and/or storage of an RV or accessory recreational vehicle must be on a pad or driveway constructed of concrete, asphalt, gravel or other material suitable for permanent vegetation control;
- (7) No RV storage structure or cover may be constructed without a properly issued building permit from the city; and
 - (8) Only 1 large recreational or special vehicle may be stored per lot.
- (C) Any business dealing in the sale of any class of RV may allow prospective buyers to utilize the RV for a trial/demonstration period not to exceed 72 hours and only on the business property. The business must dispose of all waste in accordance with all current city, county, state and federal regulations.
- (D) Any request involving special circumstances that might require exemption or exception to these ordinances must be presented to the City Secretary/Administrator for appropriate consideration and action. Approved exemption permits may be issued by the city office at a cost of \$15 and will not exceed 72 hours in duration per permitted period.
- (E) In event of a violation of any provision of this section, the city will inform by letter the person(s) of the violation(s) and outline action needed to resolve the problem. A period of 10 days after date of receipt of the letter will be permitted to comply with this section. Noncompliance after the 10-day grace period will result in the issuance of a citation and a fine as set forth in § 70.99. (Ord. 05-18-02, passed 5-18-2006; Am. § 70.17 HANDICAP PARKING.

It shall be unlawful for any person to park any vehicle in the designated handicap parking space on West Bermuda Street unless the vehicle is used to transport persons with temporary or permanent disabilities and is so designated by a placard or license plate. (Ord. 06-21-07-01, passed 6-21-2007)

§ 70.99 PENALTY.

- (A) (1) Whenever in this title an act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or wherever in this title the doing of any act is required or the failure to do any act is declared to be unlawful, and no specific penalty is otherwise provided in this code of ordinances, the violation shall be punished by a fine not exceeding \$500; provided, however, that no penalty shall be greater or less than the penalty provided for the same or a similar offense of the laws of the state.
- (2) Each day a violation of this code or of any ordinance continues shall constitute a separate offense.
- (B) Any person, firm or corporation violating any provisions of § 70.01 or Chapter 72, Schedule I or failing to observe any provisions hereof shall be deemed guilty of a misdemeanor and upon conviction shall be fined in any sum not exceeding \$200. Each and every violation shall be considered a separate offense.

- (C) Any person convicted for the violation of § 70.15 shall be punished by a fine not to exceed \$200 and all illegally parked vehicles are subject to be towed away. (Ord. 960815, passed 8-15-1996)
- (D) For violations of § 70.16, noncompliance after the 10-day grace period will result in the issuance of a citation and a fine of \$250. Any further violation(s) will result in citations and daily fines of \$25.

- (E) Any person convicted for the violation of § 70.17 shall be punished by a fine of \$250 \$1,000 and any illegally parked vehicle is subject to be towed away. (Ord. 06-21-07-01, passed 6-21-2007)
- (F) Any person convicted for violation of speed limit and 1-way regulations for Paul Street, as set forth in Chapter 72, Schedules I and IV, shall be punished by a fine not to exceed \$200. (Ord. 981015R, passed -)

§ 71.01 TRUCK ROUTING AND PARKING; LOAD LIMITS.

- (A) Truck routes established for local delivery. No person shall operate or park a commercial vehicle having a rated capacity greater than 2 tons upon any street other than on through streets as designated by this section, except when necessary to leave the through streets for the purpose of delivering or picking up materials or merchandise at some location not on a through street, which delivery or pickup to be accomplished by the shortest practical route. The provisions of this division shall not apply to vehicles owned and operated by governmental agencies or public utility companies while engaged in the customary maintenance, construction, or repair functions.
- (B) *Truck routes established for "through" vehicles*. No person shall operate or park a commercial vehicle having a rated capacity of over 2 tons when the vehicle is routed to pass through the city, without stopping for loading or unloading, except over streets designated as through streets (or truck routes).
- (C) *Truck routes (or through streets) designated.* The streets set forth in Chapter 72, Schedule II are declared to be through streets for the purpose of this section.
- (D) Maximum vehicle load limit on designated streets. The maximum vehicle load limit on any street of the city, other than those streets designated as U.S. or state highways, shall not exceed a single axle load of 12,000 pounds, a tandem axle load of 24,000 pounds, and a gross vehicle weight of 72,000 pounds, unless otherwise permitted by the State of Texas.

§ 71.02 TRUCK PARKING PROHIBITED.

It shall hereafter be unlawful for any person to park a truck on the streets designated in Chapter 73, Schedule I.

§ 71.03 ENGINE (JAKE) BRAKE USE PROHIBITED.

This section hereby restricts the use of any motor brake (jake brake) within the City of Quitman. (Ord. 050421, passed 4-21-2005) Penalty, see § 71.99

§ 71.99 PENALTY.

- (A) Any person who violates any provision of this chapter for which no penalty is provided shall be subject to the terms of § 10.99.
- (B) Any person who violates any of the provisions of § 71.01 shall, upon conviction thereof, be fined not less than \$25, nor more than \$200, and each violation shall be considered a separate offense. (Ord. 980219, passed 2-19-1998)
- (C) Any person convicted for a violation of § 71.02 shall be punished by a fine not to exceed \$200. Each and every violation shall be considered a separate offense. (Ord. 010216, passed 2-15-2001)
- (D) Any person violating § 71.03 shall be guilty of a misdemeanor and upon conviction hereof shall be punished by a fine not exceeding \$200. (Ord. 050421, passed 4-21-2005)
